NIGERIA.

Dear Selie,

I am Benister Paul Useni, a Solicitor and the Personal Attorney to Mr. Thomas Siale, a national of your country, who used to work with the Oil Petroleum Development Company in Nigeria. On the 2nd of May 2002, my client, his wife and their three children were involved in a car accident here in Nigeria. All 5 of them lost their lives including our spot in Nigeria.

Since then, I have made several enquiries to their embassy to help locate any of my client's extended relatives, this has also proved unsuccessful. After these several unsuccessful attempts, I decided to track his relatives to see the funeral to locate any member of his family but to no avail, hence I contacted you. I have contacted you to assist in repatriating the money that belong to my late client before they get confiscated or declared as untraceable by the bank where his huge deposit were lodged.

Particularly, the Bank where the deceased had an account valued at about \$45.5 Million Dollars, has allowed me a note to provide the need of him or have the account confiscated within the median official working days. Since I have been unsuccessful in locating the relatives for over 2 years now.

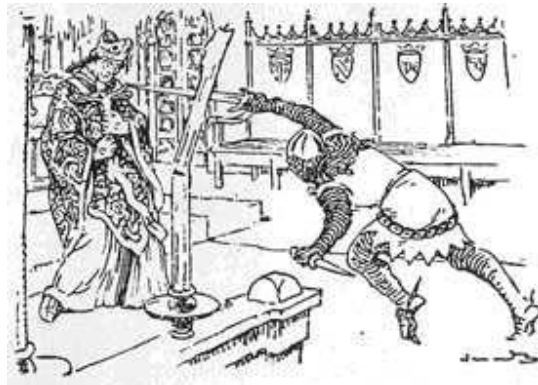

Menu Structure

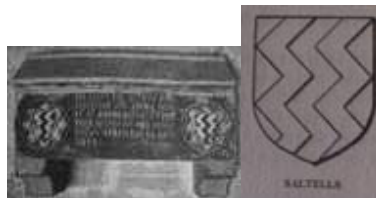
